

## SCALES LAKE PARK & CAMPGROUND RULES & REGULATIONS

1. **2 Vehicles are allowed on each campsite. NO EXCEPTIONS.** Any additional vehicles must park in the parking lot by the front entrance.
2. **No more than 6 persons will be permitted on any campsite. Park Staff may limit the number of tents, vehicles, and/or people on each campsite. The established capacity of a campsite may not be exceeded.**
3. **No more than two tents of reasonable size will be allowed on any campsite. No tents are allowed on full hook up sites (sites 35 through 85).**
4. All campers camping in a tent will have a 3 day limit and then will have to vacate the park for at least 7 days before they may return. Sleeping in passenger vehicles is prohibited. All campers camping in a camper/RV will have a 30 day limit and then will have to vacate the park for at least 14 days before they return.
5. One responsible individual is required to register personally for his group or family with park staff for each site.
6. Campers under 18 years of age must be accompanied by an adult or obtain prior special permission from park staff.
7. No camp(site) of any type shall be located except in places designated as your camp(site) by the department for that purpose.
8. The camping fee, to be paid in advance, shall entitle the group or family to occupy one campsite for a 24- hour period extending from noon to noon.
9. Sub-Leasing of campsites or personally owned equipment on a site is prohibited.
10. Camping equipment must have a current license plate, be in good mechanical condition, and have a good general appearance.

11. Fires are permitted only in stoves, grills, or designated areas. All fires must be completely extinguished before a campsite is vacated.
12. The washing of dishes or pets at drinking fountains, bathroom sinks, or laundry tubs is prohibited. The washing of recreational vehicles, automobiles, or boats in the camping areas is prohibited.
13. The use and possession of fireworks is prohibited at all times in the camping area and park.
14. The campground permit must be posted where park staff can readily inspect it.
15. Quiet hours are mandatory and will be observed from 11:00 p.m. to 7:00 a.m. No camps are to be set up in the campground during the quiet hours.
16. All terrain motor vehicles are not permitted in the park. Golf Carts and Mopeds are allowed in the park. Any person operating a Golf Cart or Moped must be 16 years of age and have a valid driver's license.
17. Motor vehicles must be driven or parked only at places provided thereof.
18. There will be no bikes, skateboards, or scooters of any kind allowed on the sidewalks at the shower house or petting zoo. Riding bikes after dark is prohibited.
19. No person shall injure, destroy, remove, mutilate, or deface any building, structure, sign, rock, tree, shrub, vine, or property whatsoever; or pick any flowers; nor take, kill, injure, pursue, harm or shoot any wild animal. The collection of firewood is included in this rule.

20. Private notices or advertisements shall not be posted in the park without the express written permission of the Superintendent under guidelines established by the Board. No person or entity shall engage in any commercial business or enterprise of any nature in the park without the written permission of the Superintendent under guidelines established by the Board.
21. Campground fees are applicable year round; there are no "winter rates".
22. All trash and garbage is to be placed in plastic trash bags and placed in the trash trailer located by the dump station and shall not be thrown or scattered on the ground or in the water.
23. Swimming is permitted only in the designated area and only when supervised by the authorized lifeguards on duty at the time. No flotation devices of any kind allowed in the swimming area. Exceptions to the flotation device rule may be made by the Park Superintendent in special situations.
24. Boat launching area shall be used for the purpose of launching and removing boats only. Vehicles and boat trailers must be parked in designated areas.
25. No person shall run or operate any motor vehicle at a greater rate of speed than fifteen miles per hour.
26. Aircraft shall not be allowed in the park.
27. Watercraft propelled by motor or motors shall not be permitted except by electric trolling motors powered by a 12-volt battery.
28. Kayaks and canoes are allowed on the lake. U.S. Coast Guard approved inflatable boats are allowed on the lake. All persons in any type of boat must have a U.S. Coast Guard approved flotation device. Paddle boards are not allowed on the lake.
29. All Indiana fishing and boating laws apply at Scales Lake Park.
30. Pets must be kept on a leash no longer than 6 feet and shall be personally attended to at all times while in the park. Owners responsible for the animal not creating a disturbance of any kind and for proper clean up for sanitary purposes. **No pets are allowed in the family cabins and surrounding areas. No pets are allowed in any park building or structure except those which must be used by their handicap owners (example: service dogs).**
31. The use of generators is prohibited.
32. Park Staff may make other rules and regulations to ensure smooth functioning of the park. The Superintendent has authority to terminate on cause any occupancy at any time.
